CHAPTER 697—S. F. No. 130

An act relating to probation officers; changing the amount to be paid to counties in reimbursement of costs of certain probation services; amending Minnesota Statutes 1961, Section 260.311, Subdivision 5, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 260.311, Subdivision 5, as amended by Laws 1963, Chapter 694, Section 1, is amended to read:

Subd. 5. **Probation officers; reimbursement of counties.** In order to reimburse the counties for the cost which they assume under Laws 1959, Chapter 698, of providing probation and parole services to wards of the youth conservation commission and to aid the counties in achieving the purposes of this section, the state shall annually, from state funds appropriated for that purpose, pay *50 percent of such costs* to all counties of not more than 100,000 population *ten cents for each resident of the county; as determined by the most recent population estimate made by the department of health.* Nothing herein shall be deemed to invalidate any payments to counties made pursuant to this section before the effective date of this act.

Sec. 2. *This act takes effect on July 1, 1965.*

CHAPTER 698—S. F. No. 163

[Coded in Part]

An act relating to the board of tax appeals; providing for a change of name and the compensation of its members; amending Minnesota Statutes 1961, Section 271.01, Subdivision 4.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [271.001] **Tax court; change of name.** *The name of the board of tax appeals is hereby changed to the tax court. The tax court shall exercise all powers and duties vested in or imposed on the board of tax appeals as existing and constituted immediately prior to the enactment of this section.*

Sec. 2. Minnesota Statutes 1961, Section 271.01, Subdivision 4, is amended to read:

Subd. 4. **Compensation.** Each member of the ~~board~~ tax court shall receive ~~\$25~~ \$45 per day as full compensation for time spent in the performance of his duties, but not exceeding compensation for 150 days in any calendar year, or a proportionate amount for a fraction of a year. He shall also receive his actual and necessary expenses paid or incurred in the performance of his duties.

Sec. 3. *The revisor of statutes shall substitute the words "tax court" for the words "board of tax appeals" and the word "board" when it refers to the board of tax appeals wherever they appear in the statutes.*

CHAPTER 699—S. F. No. 245

[Not Coded]

An act relating to the salary of the auditor of Pope county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Pope county; auditor; salary.** Notwithstanding the provisions of any other law to the contrary, the annual salary of the county auditor of Pope county shall be set by the board of county commissioners in an amount not to exceed \$6,200 per year.

Sec. 2. The aforesaid salary shall constitute the base salary and the auditor shall be entitled to any cost of living increases hereafter granted under the provisions of Minnesota Statutes, Section 375.43, and acts amendatory thereof or supplementary thereto.

Sec. 3. Nothing contained in section 1 shall be construed as limiting the right of the auditor to collect and retain fees, per diem payments, or any other payment which he is now authorized to collect in addition to the stated amount of his monthly salary.
