

tinued residency in Minnesota, United States citizenship, satisfactory academic standing and recommendation of the college and, in the case of financial assistance, evidence of continued need.

(6) The student must apply for renewal of his scholarship each year.

(7) The student must continue to attend an eligible institution.

(8) All scholarship winners shall be notified of their award by the commission and shall be given appropriate evidence of the award.

(9) Financial scholarships awarded under the terms of this act shall be applied to basic educational costs in the following order; tuition, fees and books, and supplies. Unpaid portions of such awards shall revert to the commission scholarship account.

Sec. 5. [136A.13] **Accounting and records.** Subdivision 1. **Accounts.** The commission shall establish and maintain appropriate scholarship accounts and related records of each recipient of a scholarship awarded.

Subd. 2. **Rules; payment and accounting.** The commission shall provide by rule the method of payment of the scholarships awarded hereunder and prescribe a system of accounting to be kept by the institution selected by a recipient.

Subd. 3. **Certification to state auditor.** Upon proper verification for payment of a scholarship as defined herein, the commission shall certify to the state auditor the amount of the current payment to be made to the scholarship winner in conformance with the rule of the commission governing the method of payment.

CHAPTER 872—H. F. No. 501

An act relating to education; special instruction for handicapped children; amending Minnesota Statutes 1965, Section 120.17, Subdivision 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 120.17, Subdivision 1, is amended to read:

120.17 **Handicapped children.** Subdivision 1. **Special instruction for handicapped children.** Every district and unorganized territory shall provide special instruction and services for handicapped children of school age who are residents of the district. School age means the ages of four years to 21 years for children who are deaf, blind, crippled or have speech defects; and five years to 21 years for mentally retarded children; and shall not extend beyond secondary school or its equivalent. *Every district and unorganized territory may provide special instruction and services for handicapped children who have not attained school age.*

CHAPTER 873—H. F. No. 562

An act authorizing the issuance and sale of Minnesota trunk highway bonds under the provisions of Minnesota Constitution, Article IX, Section 6, and Article XVI, Section 12; and the expenditure of the proceeds thereof and appropriating money in connection therewith.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Trunk highway bonds; issuance and sale. The state auditor is authorized and directed, upon request of the commissioner of highways, to issue and sell Minnesota trunk highway bonds under the provisions of Minnesota Statutes, Sections 167.50 to 167.52 and of the Minnesota Constitution, Article IX, Section 6, and Article XVI, Section 12, at such times and in such amounts as may be requested by the commissioner of highways. Bonds issued under the authority of this section shall not exceed an aggregate principal amount of \$100 million. The proceeds of such bonds shall be appropriated to the trunk highway fund and shall be used for the purposes specified in Minnesota Constitution, Article XVI, Section 2.

Sec. 2. Of the proceeds of the bonds issued pursuant to section 1, not more than \$20,000,000 thereof shall be expended in any one fiscal year beginning July 1, 1967.
