Subd. 5. SPECIAL INSPECTION. Any person owning or operating bees or bee equipment who wishes special inspection service covering inspection of his bees prior to or after the regular inspection is conducted in his locality, may apply to the commissioner for such service, agreeing in his application to pay a predetermined mutually agreed upon fee for such special service.

Sec. 4. Minnesota Statutes 1971, Chapter 19, is amended by adding a section to read:

[19.41] POSTING STATEMENT OF OWNERSHIP. Any owner or possessor of an apiary shall, unless such apiary is located at owner's place of residence or beekeeping headquarters, post and keep posted in a prominent place at each apiary a statement of the ownership of the apiary, including thereon the name and address of the owner.

CHAPTER 36—H.F.No.1184

An act relating to cities; prohibiting resigning member of city council from voting on his successor.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **[415.15] MUNICIPALITIES; CITY COUNCIL RESIGNATIONS, VOTING ON SUCCESSOR.** No resigning member of a city council shall participate in a vote of the council to choose a person to replace the resigning member.

CHAPTER 37—H.F.No.1196

An act relating to education; the function of the principal in the public schools in the state of Minnesota; amending Minnesota Statutes 1971, Section 123.34, by adding a subdivision.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1971, Section 123.34, is amended by adding a subdivision to read:

Subd. 10. SCHOOLS AND SCHOOL DISTRICTS; PRINCIPALS. Each school building or unit of classification as designated by section 120.05, subdivision 1, clauses (1), (2) and (3), in an independent or consolidated school district shall be under the supervision of a principal who is assigned to that responsibility by the board of education in that school district upon the recommendation of the superintendent of schools of that school district.

Each principal assigned the responsibility for the supervision of a school building or units of classification shall hold valid certification in his assigned position of supervision and administration as established by the regulations of the state board of education.

The principal shall provide administrative, supervisory and instructional leadership services, under the supervision of the superintendent of schools of the school district and in accordance with the policies, rules and regulations of the board of education, for the planning, management, operation and evaluation of the education program of the building or buildings to which he is assigned.

CHAPTER 38—H.F.No.1211

An act relating to rates for publication of legal notices; amending Minnesota Statutes 1971, Sections 3.21 and 331.08.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1971, Section 3.21, is amended to read:

3.21 LEGAL NOTICES; PUBLICATION RATES. At least four months preceding such election, the attorney general shall furnish to the secretary of state a statement of the purpose and effect of all amendments proposed showing clearly the form of the existing sections, and of the same as they will read if amended, except that when any section to which an amendment is proposed exceeds 150 words in length, the statement shall show that part of the section in which a change is proposed, both in its existing form and as it will read when amended, together with such portions of the context as the attorney general deems necessary to an understanding of the proposed amendment. In the month of October prior to the election, the secretary of state shall give two weeks published notice of such statement in all legal newspapers of the state.
