1.9	(a) For purposes of this chapter and unless the context clearly requires otherwise, the
1.10	definitions in this section have the meanings given them.
1.11	(b) "Address" means a residential street address, school address, or work address
1.12	of an individual, as specified on the individual's application to be a program participant
1.13	under this chapter.
1.14	(c) "Applicant" means an adult, a parent or guardian acting on behalf of an eligible
1.15	minor, or a guardian acting on behalf of an incapacitated person, as defined in section
