14.23 date of this section located along the marked
14.24 Interstate Highway 494 corridor. Permissible
14.25 uses include administrative expenses and
14.26 programming and service expansion,
14.27 including but not limited to staffing,
14.28 communications, outreach and education
14.29 program development, and operations
14.30 management. The council may not retain any
