(b) Notwithstanding paragraph (a), district courts in the Tenth Judicial District may 2.27 order, as a condition of a release, a person arrested on a charge of a crime described 2.28 in section 609.135, subdivision 5a, paragraph (b), to use an electronic monitoring 2.29 device to protect the victim's safety.
