1.15 We, the undersigned conferees for S.F. No. 2935 report that we have agreed upon
1.16 the items in dispute and recommend as follows:

1.17 That the Senate concur in the House amendment and that S.F. No. 2935 be further
1.18 amended as follows:

1.19 Delete everything after the enacting clause and insert:

1.20 "ARTICLE 1

1.21 LICENSING

1.22 Section 1. Minnesota Statutes 2008, section 144A.071, subdivision 4c, is amended to
1.23 read:

1.24 Subd. 4c. **Exceptions for replacement beds after June 30, 2003.** (a) The
1.25 commissioner of health, in coordination with the commissioner of human services, may
1.26 approve the renovation, replacement, upgrading, or relocation of a nursing home or
1.27 boarding care home, under the following conditions:

1.28 (1) to license and certify an 80-bed city-owned facility in Nicollet County to be
1.29 constructed on the site of a new city-owned hospital to replace an existing 85-bed facility
1.30 attached to a hospital that is also being replaced. The threshold allowed for this project

2.1 under section 144A.073 shall be the maximum amount available to pay the additional
2.2 medical assistance costs of the new facility;

2.3 (2) to license and certify 29 beds to be added to an existing 69-bed facility in St.
2.4 Louis County, provided that the 29 beds must be transferred from active or layaway status
2.5 at an existing facility in St. Louis County that had 235 beds on April 1, 2003.

2.6 The licensed capacity at the 235-bed facility must be reduced to 206 beds, but the payment
2.7 rate at that facility shall not be adjusted as a result of this transfer. The operating payment
2.8 rate of the facility adding beds after completion of this project shall be the same as it was
2.9 on the day prior to the day the beds are licensed and certified. This project shall not
2.10 proceed unless it is approved and financed under the provisions of section 144A.073;

2.11 (3) to license and certify a new 60-bed facility in Austin, provided that: (i) 45 of
2.12 the new beds are transferred from a 45-bed facility in Austin under common ownership
2.13 that is closed and 15 of the new beds are transferred from a 182-bed facility in Albert Lea
2.14 under common ownership; (ii) the commissioner of human services is authorized by the
2.15 2004 legislature to negotiate budget-neutral planned nursing facility closures; and (iii)
2.16 money is available from planned closures of facilities under common ownership to make
2.17 implementation of this clause budget-neutral to the state. The bed capacity of the Albert
2.18 Lea facility shall be reduced to 167 beds following the transfer. Of the 60 beds at the
2.19 new facility, 20 beds shall be used for a special care unit for persons with Alzheimer's
2.20 disease or related dementias;

2.21 (4) to license and certify up to 80 beds transferred from an existing state-owned
2.22 nursing facility in Cass County to a new facility located on the grounds of the
2.23 Ah-Gwah-Ching campus. The operating cost payment rates for the new facility shall be
2.24 determined based on the interim and settle-up payment provisions of Minnesota Rules,
2.25 part 9549.0057, and the reimbursement provisions of section 256B.431. The property
2.26 payment rate for the first three years of operation shall be \$35 per day. For subsequent
2.27 years, the property payment rate of \$35 per day shall be adjusted for inflation as provided
2.28 in section 256B.434, subdivision 4, paragraph (c), as long as the facility has a contract
2.29 under section 256B.434; ~~and~~

2.30 (5) to initiate a pilot program to license and certify up to 80 beds transferred from
2.31 an existing county-owned nursing facility in Steele County relocated to the site of a new
2.32 acute care facility as part of the county's Communities for a Lifetime comprehensive plan
2.33 to create innovative responses to the aging of its population. Upon relocation to the new
2.34 site, the nursing facility shall delicense 28 beds. The property payment rate for the first
2.35 three years of operation of the new facility shall be increased by an amount as calculated
2.36 according to items (i) to (v):

3.1 (i) compute the estimated decrease in medical assistance residents served by the
3.2 nursing facility by multiplying the decrease in licensed beds by the historical percentage
3.3 of medical assistance resident days;

3.4 (ii) compute the annual savings to the medical assistance program from the
3.5 delicensure of 28 beds by multiplying the anticipated decrease in medical assistance
3.6 residents, determined in item (i), by the existing facility's weighted average payment rate
3.7 multiplied by 365;

3.8 (iii) compute the anticipated annual costs for community-based services by
3.9 multiplying the anticipated decrease in medical assistance residents served by the nursing
3.10 facility, determined in item (i), by the average monthly elderly waiver service costs for
3.11 individuals in Steele County multiplied by 12;

3.12 (iv) subtract the amount in item (iii) from the amount in item (ii);

3.13 (v) divide the amount in item (iv) by an amount equal to the relocated nursing
3.14 facility's occupancy factor under section 256B.431, subdivision 3f, paragraph (c),
3.15 multiplied by the historical percentage of medical assistance resident days.

3.16 For subsequent years, the adjusted property payment rate shall be adjusted for
3.17 inflation as provided in section 256B.434, subdivision 4, paragraph (c), as long as the
3.18 facility has a contract under section 256B.434-; and

3.19 (6) to consolidate and relocate nursing facility beds to a new site in Goodhue County
3.20 and to integrate these services with other community-based programs and services under a
3.21 communities for a lifetime pilot program and comprehensive plan to create innovative
3.22 responses to the aging of its population. Eighty beds in the city of Red Wing shall be
3.23 transferred from the downsizing and relocation of an existing 84-bed, hospital-owned
3.24 nursing facility and the entire closure or downsizing of beds from a 65-bed nonprofit
3.25 nursing facility in the community resulting in the delicensure of 69 beds in the two
3.26 existing facilities. Notwithstanding the carryforward of the approval authority in section
3.27 144A.073, subdivision 11, the funding approved in April 2009 by the commissioner of
3.28 health for a project in Goodhue County shall not carry forward. The closure of the 69 beds
3.29 shall not be eligible for a planned closure rate adjustment under section 256B.437. The
3.30 construction project permitted in this clause shall not be eligible for a threshold project
3.31 rate adjustment under section 256B.434, subdivision 4f. The property payment rate for
3.32 the first three years of operation of the new facility shall be increased by an amount as
3.33 calculated according to items (i) to (vi):

3.34 (i) compute the estimated decrease in medical assistance residents served by both
3.35 nursing facilities by multiplying the difference between the occupied beds of the two
3.36 nursing facilities for the reporting year ending September 30, 2009, and the projected

4.1 occupancy of the facility at 95 percent occupancy by the historical percentage of medical
4.2 assistance resident days;

4.3 (ii) compute the annual savings to the medical assistance program from the
4.4 delicensure by multiplying the anticipated decrease in the medical assistance residents,
4.5 determined in item (i), by the hospital-owned nursing facility weighted average payment
4.6 rate multiplied by 365;

4.7 (iii) compute the anticipated annual costs for community-based services by
4.8 multiplying the anticipated decrease in medical assistance residents served by the
4.9 facilities, determined in item (i), by the average monthly elderly waiver service costs for
4.10 individuals in Goodhue County multiplied by 12;

4.11 (iv) subtract the amount in item (iii) from the amount in item (ii);

4.12 (v) multiply the amount in item (iv) by 48.5 percent; and

4.13 (vi) divide the difference of the amount in item (iv) and the amount in item (v) by an
4.14 amount equal to the relocated nursing facility's occupancy factor under section 256B.431,
4.15 subdivision 3f, paragraph (c), multiplied by the historical percentage of medical assistance
4.16 resident days.

4.17 For subsequent years, the adjusted property payment rate shall be adjusted for
4.18 inflation as provided in section 256B.434, subdivision 4, paragraph (c), as long as the
4.19 facility has a contract under section 256B.434.

4.20 (b) Projects approved under this subdivision shall be treated in a manner equivalent
4.21 to projects approved under subdivision 4a.

4.22 Sec. 2. Minnesota Statutes 2009 Supplement, section 245A.03, subdivision 2, is
4.23 amended to read:

4.24 Subd. 2. **Exclusion from licensure.** (a) This chapter does not apply to:

4.25 (1) residential or nonresidential programs that are provided to a person by an
4.26 individual who is related unless the residential program is a child foster care placement
4.27 made by a local social services agency or a licensed child-placing agency, except as
4.28 provided in subdivision 2a;

4.29 (2) nonresidential programs that are provided by an unrelated individual to persons
4.30 from a single related family;

4.31 (3) residential or nonresidential programs that are provided to adults who do
4.32 not abuse chemicals or who do not have a chemical dependency, a mental illness, a
4.33 developmental disability, a functional impairment, or a physical disability;

4.34 (4) sheltered workshops or work activity programs that are certified by the
4.35 commissioner of employment and economic development;

- 5.1 (5) programs operated by a public school for children 33 months or older;
- 5.2 (6) nonresidential programs primarily for children that provide care or supervision
5.3 for periods of less than three hours a day while the child's parent or legal guardian is in
5.4 the same building as the nonresidential program or present within another building that is
5.5 directly contiguous to the building in which the nonresidential program is located;
- 5.6 (7) nursing homes or hospitals licensed by the commissioner of health except as
5.7 specified under section 245A.02;
- 5.8 (8) board and lodge facilities licensed by the commissioner of health that do not
5.9 ~~provide services for five or more persons whose primary diagnosis is mental illness that do~~
5.10 ~~not provide intensive residential treatment~~ children's residential services under Minnesota
5.11 Rules, chapter 2960, mental health or chemical dependency treatment;
- 5.12 (9) homes providing programs for persons placed by a county or a licensed agency
5.13 for legal adoption, unless the adoption is not completed within two years;
- 5.14 (10) programs licensed by the commissioner of corrections;
- 5.15 (11) recreation programs for children or adults that are operated or approved by a
5.16 park and recreation board whose primary purpose is to provide social and recreational
5.17 activities;
- 5.18 (12) programs operated by a school as defined in section 120A.22, subdivision 4;
5.19 YMCA as defined in section 315.44; YWCA as defined in section 315.44; or JCC as
5.20 defined in section 315.51, whose primary purpose is to provide child care or services to
5.21 school-age children;
- 5.22 (13) Head Start nonresidential programs which operate for less than 45 days in
5.23 each calendar year;
- 5.24 (14) noncertified boarding care homes unless they provide services for five or more
5.25 persons whose primary diagnosis is mental illness or a developmental disability;
- 5.26 (15) programs for children such as scouting, boys clubs, girls clubs, and sports and
5.27 art programs, and nonresidential programs for children provided for a cumulative total of
5.28 less than 30 days in any 12-month period;
- 5.29 (16) residential programs for persons with mental illness, that are located in hospitals;
- 5.30 (17) the religious instruction of school-age children; Sabbath or Sunday schools; or
5.31 the congregate care of children by a church, congregation, or religious society during the
5.32 period used by the church, congregation, or religious society for its regular worship;
- 5.33 (18) camps licensed by the commissioner of health under Minnesota Rules, chapter
5.34 4630;
- 5.35 (19) mental health outpatient services for adults with mental illness or children
5.36 with emotional disturbance;

6.1 (20) residential programs serving school-age children whose sole purpose is cultural
6.2 or educational exchange, until the commissioner adopts appropriate rules;

6.3 (21) unrelated individuals who provide out-of-home respite care services to persons
6.4 with developmental disabilities from a single related family for no more than 90 days in a
6.5 12-month period and the respite care services are for the temporary relief of the person's
6.6 family or legal representative;

6.7 (22) respite care services provided as a home and community-based service to a
6.8 person with a developmental disability, in the person's primary residence;

6.9 (23) community support services programs as defined in section 245.462, subdivision
6.10 6, and family community support services as defined in section 245.4871, subdivision 17;

6.11 (24) the placement of a child by a birth parent or legal guardian in a preadoptive
6.12 home for purposes of adoption as authorized by section 259.47;

6.13 (25) settings registered under chapter 144D which provide home care services
6.14 licensed by the commissioner of health to fewer than seven adults;

6.15 (26) chemical dependency or substance abuse treatment activities of licensed
6.16 professionals in private practice as defined in Minnesota Rules, part 9530.6405, subpart
6.17 15, when the treatment activities are not paid for by the consolidated chemical dependency
6.18 treatment fund;

6.19 (27) consumer-directed community support service funded under the Medicaid
6.20 waiver for persons with developmental disabilities when the individual who provided
6.21 the service is:

6.22 (i) the same individual who is the direct payee of these specific waiver funds or paid
6.23 by a fiscal agent, fiscal intermediary, or employer of record; and

6.24 (ii) not otherwise under the control of a residential or nonresidential program that is
6.25 required to be licensed under this chapter when providing the service; or

6.26 (28) a program serving only children who are age 33 months or older, that is
6.27 operated by a nonpublic school, for no more than four hours per day per child, with no
6.28 more than 20 children at any one time, and that is accredited by:

6.29 (i) an accrediting agency that is formally recognized by the commissioner of
6.30 education as a nonpublic school accrediting organization; or

6.31 (ii) an accrediting agency that requires background studies and that receives and
6.32 investigates complaints about the services provided.

6.33 A program that asserts its exemption from licensure under item (ii) shall, upon
6.34 request from the commissioner, provide the commissioner with documentation from the
6.35 accrediting agency that verifies: that the accreditation is current; that the accrediting

7.1 agency investigates complaints about services; and that the accrediting agency's standards
7.2 require background studies on all people providing direct contact services.

7.3 (b) For purposes of paragraph (a), clause (6), a building is directly contiguous to a
7.4 building in which a nonresidential program is located if it shares a common wall with the
7.5 building in which the nonresidential program is located or is attached to that building by
7.6 skyway, tunnel, atrium, or common roof.

7.7 (c) Nothing in this chapter shall be construed to require licensure for any services
7.8 provided and funded according to an approved federal waiver plan where licensure is
7.9 specifically identified as not being a condition for the services and funding.

7.10 Sec. 3. Minnesota Statutes 2008, section 245A.03, is amended by adding a subdivision
7.11 to read:

7.12 **Subd. 9. Permitted services by an individual who is related.** Notwithstanding
7.13 subdivision 2, paragraph (a), clause (1), and subdivision 7, an individual who is related to a
7.14 person receiving supported living services may provide licensed services to that person if:

7.15 (1) the person who receives supported living services received these services in a
7.16 residential site on July 1, 2005;

7.17 (2) the services under clause (1) were provided in a corporate foster care setting for
7.18 adults and were funded by the developmental disabilities home and community-based
7.19 services waiver defined in section 256B.092;

7.20 (3) the individual who is related obtains and maintains both a license under
7.21 chapter 245B and an adult foster care license under Minnesota Rules, parts 9555.5105
7.22 to 9555.6265; and

7.23 (4) the individual who is related is not the guardian of the person receiving supported
7.24 living services.

7.25 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.26 Sec. 4. Minnesota Statutes 2009 Supplement, section 245A.04, subdivision 5, is
7.27 amended to read:

7.28 **Subd. 5. Commissioner's right of access.** When the commissioner is exercising
7.29 the powers conferred by this chapter and sections 245.69, 626.556, and 626.557, the
7.30 commissioner must be given access to the physical plant and grounds where the program
7.31 is provided, documents and records, including records maintained in electronic format,
7.32 persons served by the program, and staff whenever the program is in operation and the
7.33 information is relevant to inspections or investigations conducted by the commissioner.
7.34 The commissioner must be given access without prior notice and as often as the

8.1 commissioner considers necessary if the commissioner is ~~conducting an investigation~~
8.2 ~~of allegations of~~ investigating alleged maltreatment or other, conducting a licensing
8.3 inspection, or investigating an alleged violation of applicable laws or rules. In conducting
8.4 inspections, the commissioner may request and shall receive assistance from other state,
8.5 county, and municipal governmental agencies and departments. The applicant or license
8.6 holder shall allow the commissioner to photocopy, photograph, and make audio and video
8.7 tape recordings during the inspection of the program at the commissioner's expense. The

8.12 to fully comply with this subdivision is reasonable cause for the commissioner to deny the
8.13 application or immediately suspend or revoke the license.

8.15 amended to read:

8.16 Subd. 7. **Grant of license; license extension.** (a) If the commissioner determines
8.17 that the program complies with all applicable rules and laws, the commissioner shall issue
8.18 a license. At minimum, the license shall state:

- 8.19 (1) the name of the license holder;
- 8.20 (2) the address of the program;
- 8.21 (3) the effective date and expiration date of the license;
- 8.22 (4) the type of license;
- 8.23 (5) the maximum number and ages of persons that may receive services from the
8.24 program; and
- 8.25 (6) any special conditions of licensure.

8.26 (b) The commissioner may issue an initial license for a period not to exceed two
8.27 years if:

- 8.28 (1) the commissioner is unable to conduct the evaluation or observation required
8.29 by subdivision 4, paragraph (a), clauses (3) and (4), because the program is not yet

9.4 approval before making any changes that would alter the license information listed under
9.5 paragraph (a).

9.6 (e) Except as provided in paragraphs (g) and (h), the commissioner shall not issue or
9.7 reissue a license if the applicant, license holder, or controlling individual has:

9.8 (1) been disqualified and the disqualification was not set aside and no variance has
9.9 been granted;

9.10 (2) has been denied a license within the past two years;

9.11 (3) had a license revoked within the past five years; or

9.12 (4) has an outstanding debt related to a license fee, licensing fine, or settlement
9.13 agreement for which payment is delinquent.

9.14 When a license is revoked under clause (1) or (3), the license holder and controlling
9.15 individual may not hold any license under chapter 245A or 245B for five years following
9.16 the revocation, and other licenses held by the applicant, license holder, or controlling
9.17 individual shall also be revoked.

9.18 (f) The commissioner shall not issue or reissue a license if an individual living in
9.19 the household where the licensed services will be provided as specified under section
9.20 245C.03, subdivision 1, has been disqualified and the disqualification has not been set
9.21 aside and no variance has been granted.

9.22 (g) Pursuant to section 245A.07, subdivision 1, paragraph (b), when a license has
9.23 been suspended or revoked and the suspension or revocation is under appeal, the program
9.24 may continue to operate pending a final order from the commissioner. If the license under
9.25 suspension or revocation will expire before a final order is issued, a temporary provisional
9.26 license may be issued provided any applicable license fee is paid before the temporary

10.6 be considered an extension of the license for a period of no more than 30 calendar days or

10.14 a tribal licensing authority has established jurisdiction to license the program or service.

10.18 Subdivision 1. **Sanctions; appeals; license.** (a) In addition to making a license
10.19 conditional under section 245A.06, the commissioner may suspend or revoke the license,
10.20 impose a fine, or secure an injunction against the continuing operation of the program of a
10.21 license holder who does not comply with applicable law or rule. When applying sanctions
10.22 authorized under this section, the commissioner shall consider the nature, chronicity, or
10.23 severity of the violation of law or rule and the effect of the violation on the health, safety,
10.24 or rights of persons served by the program.

10.25 (b) If a license holder appeals the suspension or revocation of a license and the
10.26 license holder continues to operate the program pending a final order on the appeal, ~~and~~
10.27 ~~the license expires during this time period,~~ the commissioner shall issue the license holder

11.21 of a hearing. A hearing must be conducted by an administrative law judge within 30
11.22 calendar days of the request for assignment, unless an extension is requested by either
11.23 party and granted by the administrative law judge for good cause. The commissioner shall
11.24 issue a notice of hearing by certified mail or personal service at least ten working days

42.14 has requested reconsideration of the maltreatment determination under paragraph (a) and
42.15 reconsideration of the disqualification under sections 245C.21 to 245C.27, reconsideration
42.16 of the maltreatment determination and requested reconsideration of the disqualification
42.17 shall be consolidated into a single reconsideration. If reconsideration of the maltreatment
42.18 determination is denied ~~or if the disqualification is not set aside under sections 245C.21 to~~
42.19 ~~245C.27~~ and the individual remains disqualified following a reconsideration decision, the
42.20 individual may request a fair hearing under section 256.045. If an individual requests a
42.21 fair hearing on the maltreatment determination and the disqualification, the scope of the
42.22 fair hearing shall include both the maltreatment determination and the disqualification.

42.23 (f) If a maltreatment determination or a disqualification based on serious or recurring
42.24 maltreatment is the basis for a denial of a license under section 245A.05 or a licensing
42.25 sanction under section 245A.07, the license holder has the right to a contested case hearing
42.26 under chapter 14 and Minnesota Rules, parts 1400.8505 to 1400.8612. As provided
42.27 for under section 245A.08, the scope of the contested case hearing must include the
42.28 maltreatment determination, disqualification, and licensing sanction or denial of a license.
42.29 In such cases, a fair hearing must not be conducted under section 256.045. Except for
42.30 family child care and child foster care, reconsideration of a maltreatment determination
42.31 under this subdivision, and reconsideration of a disqualification under section 245C.22,
42.32 must not be conducted when:

42.33 (1) a denial of a license under section 245A.05, or a licensing sanction under section
42.34 245A.07, is based on a determination that the license holder is responsible for maltreatment
42.35 or the disqualification of a license holder based on serious or recurring maltreatment;

43.1 (2) the denial of a license or licensing sanction is issued at the same time as the
43.2 maltreatment determination or disqualification; and

43.3 (3) the license holder appeals the maltreatment determination or disqualification, and
43.4 denial of a license or licensing sanction.

43.5 Notwithstanding clauses (1) to (3), if the license holder appeals the maltreatment
43.6 determination or disqualification, but does not appeal the denial of a license or a licensing
43.7 sanction, reconsideration of the maltreatment determination shall be conducted under
43.8 sections 626.556, subdivision 10i, and 626.557, subdivision 9d, and reconsideration of the
43.9 disqualification shall be conducted under section 245C.22. In such cases, a fair hearing
43.10 shall also be conducted as provided under sections 245C.27, 626.556, subdivision 10i, and

43.12 If the disqualified subject is an individual other than the license holder and upon
43.13 whom a background study must be conducted under chapter 245C, the hearings of all

43.16 (g) Until August 1, 2002, an individual or facility that was determined by the

43.19 1, 2001, that believes that the finding of neglect does not meet an amended definition of

43.29 a result of a reconsideration under this paragraph, the date of the original finding of a
43.30 substantiated maltreatment must be used to calculate the destruction date.

43.31 (2) For purposes of any background studies under chapter 245C, when a
43.32 determination of substantiated maltreatment has been changed as a result of a
43.33 reconsideration under this paragraph, any prior disqualification of the individual under
43.34 chapter 245C that was based on this determination of maltreatment shall be rescinded,
43.35 and for future background studies under chapter 245C the commissioner must not use the
43.36 previous determination of substantiated maltreatment as a basis for disqualification or as a
