Subd. 3. Exemptions. This act does not affect the validity of any judgment or order made or any other action taken prior to the effective date of this act under any repealed acts and does not affect the pendency of any action or proceeding instituted before the effective date of this act.

Subd. 4. Application. This act governs all actions brought after it takes effect and also all further proceedings in actions then pending in conciliation court or in municipal court upon removal except to the extent that in the opinion of the judge their application in a particular action pending when this act takes effect would not be feasible, or would work injustice, in which event the provisions existing at the time the action was brought shall govern.

Subd. 5. Laws excepted. Minnesota Statutes, Sections 480.051—480.058 are not modified by this act. Upon the adoption of any rule by the supreme court on the same subject, the provisions of this act, insofar as they are in conflict therewith, shall be of no further force or effect.

CHAPTER 438—S. F. No. 1344

An act relating to installment sales of motor vehicles; amending Minnesota Statutes 1957, Section 168.66, Subdivision 5, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 168.66, Subdivision 5, as amended by Laws 1959, Chapter 54, Section 1, is amended to read:

Subd. 5. "Motor vehicle" means any device propelled or drawn by any power other than muscular power, in, upon, or by which any person or property is, or may be transported or drawn upon a highway, excepting *building and road construction equipment not subject to motor vehicle registration*

CHAPTER 439—S. F. No. 1426

An act relating to tax levies for general village purposes in the village of Wood Lake.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Wood Lake, village of; tax levy.** In the village of Wood Lake there shall be levied annually on each dollar of the assessed valuation of the property taxable in the village, a tax for general village purposes not to exceed 50 mills.

Sec. 2. This act shall become effective only after its approval by a majority of the governing body of the village of Wood Lake, and upon compliance with the provisions of Laws 1959, Chapter 368.

CHAPTER 440—S. F. No. 1476

An act relating to the town of Fairview in Lyon county; giving certain village powers to the town.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Fairview township; village powers.** The town of Fairview in Lyon County shall have and possess the same power and the same authority now possessed by villages in this state under the laws of this state under Minnesota Statutes, Sections 462.01 to 462.23.
