

(3) The dispensing of any coupon, stamp or merchandise premium in conjunction and simultaneously with the sale of any merchandise the sale of which is not prohibited on Sunday or a holiday.

(4) The advertisement for sale of any merchandise by any newspaper, radio or television station, or other established advertising medium.

(5) The sale of restricted items on Sunday at a place of business which is regularly closed on Saturday and which was actually closed at all hours on the Saturday before the Sunday upon which such sale of restricted items occurs.

(6) Any retail sale for recreational purposes made by a vendor whose business is seasonal and whose retail establishment is not open to the public for at least four consecutive months of each year.

(7) Any sale at a state or county fair.

Sec. 5. [325.914] **Separate offenses.** Each sale of a restricted item in violation of this act is a separate offense.

Sec. 6. [325.915] **Penalty.** Any person who violates the provisions of this act is guilty of a misdemeanor for the first offense, and a gross misdemeanor for each succeeding offense. Such a person upon conviction for the first offense shall pay a fine not to exceed \$100 or be imprisoned for a period of not more than ten days; and for the second offense shall pay a fine not to exceed \$500 or be imprisoned for a period of not more than 30 days or both; and for the third or each subsequent offense shall pay a fine of not more than \$750 or be imprisoned for a period of not more than six months or both.

Sec. 7. This act shall be in effect on and after July 1, 1967.

CHAPTER 166—S. F. No. 751

An act relating to hog cholera vaccines; amending Minnesota Statutes 1965, Sections 35.50 and 35.51; repealing Minnesota Statutes 1965, Sections 35.52 and 35.53.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 35.50, is amended to read:

35.50 **Hog cholera vaccines.** *After June 30, 1959,* The sale or use of virulent blood or virulent live hog cholera virus for the prevention of hog cholera is prohibited. *After January 1, 1968,* the sale or use of modified live hog cholera virus vaccine for the prevention of hog cholera is prohibited, except that the board ~~shall~~ *may* permit the sale and use of such products whenever necessary either to protect the health of domestic animals or to qualify animals for export to other states or foreign countries.

Sec. 2. Minnesota Statutes 1965, Section 35.51, is amended to read:

35.51 **Permits to administer modified live hog cholera virus vaccine.** No person shall use or administer any product containing living hog cholera virus within this state unless he shall have been granted a permit by the board authorizing him to use or administer the same. ~~Permits for the use or administration of virulent blood or virulent hog cholera virus~~ *modified live hog cholera virus vaccine* shall be in writing and shall be issued only to licensed veterinarians.

Sec. 3. **Repealer.** *Minnesota Statutes 1965, Sections 35.52 and 35.53, are repealed.*

Sec. 4. **Effective date.** *This act is effective January 1, 1968.*

CHAPTER 167— S. F. No. 767

[Coded]

An act relating to highways, authorizing the commissioner of highways to prepare detailed plans of buildings and facilities for rest areas, tourist information centers, and weigh stations.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **[160.28] Highways; plans for rest areas, tourist information centers and weigh stations.** The provisions of any other law to the contrary notwithstanding, the commissioner of highways is hereby authorized to cause to be prepared plans and specifications and detailed designs for the construction of buildings and facilities for rest areas, tourist information centers in combination with
