Fayal in St. Louis county may issue its general obligation bonds in an amount not exceeding \$80,000 for the acquisition and betterment of a municipal building to be used as a town hall and for storage and servicing of its vehicles and equipment. Such bonds shall be authorized, issued, and sold in accordance with the provisions of Minnesota Statutes, Chapter 475.

- Sec. 2. The town board may levy taxes on all taxable property in the town for the payment of the principal of and interest on said bonds without limitation as to rate or amount; and such levy shall not reduce any other taxes levied or to be levied which are subject to any limitation by any amount whatsoever.
- Sec. 3. This act shall become effective upon its approval by a majority of the electors of the town of Fayal voting on the question at a town meeting or special town election, as determined by the town board, and upon compliance with Minnesota Statutes, Section 645.021. The question of authorizing the issuance of the bonds may be submitted to the electors at the same meeting or election, and such vote shall be effective notwithstanding the fact that section 645.021 has not then been complied with.

CHAPTER 222-H. F. No. 995

An act relating to veterans of the armed forces; defining what veterans are eligible for benefits administered by the commissioner of veterans affairs, amending Minnesota Statutes 1965, Section 197.447.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 197.447, is amended to read:

197.447 **Veteran, defined.** The word "veteran" as used in sections 197.20, 197.59, 197.601, 282.031, 282.032, 306.03 means any person honorably discharged from the armed forces of the United States who served in the Civil War, Spanish American War, Philippine Insurrection, China Relief Expedition, World War I between April 6, 1917 and November 11, 1918, both dates inclusive, World War H between on or after December 7, 1941 and September 2, 1945, both dates inclusive, or in the Korean conflict between June 27, 1950 and July 27, 1953, both dates inclusive until final cessation of all hostilities as determined by the proper state authori-

ties in order to give recognition for service performed in the following hostile actions: World War II, Korean conflict, Lebanon crisis, Berlin crisis, Quemoy and Matsu, Taiwan Straits, Cuban crisis, the Congo, Laos, the Dominican Republic and Vietnam, and to include service therein but not to exclude persons who did not have service in those areas. The word "veteran" does not include a person enlisted and accepted for active training only for a period of six months or less.

An act relating to fees charged for acquisition and maintenance of the Polk county law library.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Polk county; law library. Notwithstanding any provisions to the contrary of Laws 1939, Chapter 325, or any act amendatory thereof, each of the law library fees prescribed in sections 4, 5, and 6 of Laws 1939, Chapter 325, for the acquisition and maintenance of a county law library established pursuant to said act shall be \$2 rather than \$1 in Polk county, if and so long as a county law library established pursuant to said act is maintained in said county.
- Sec. 2. This act shall be in effect upon approval of the governing body of Polk county and upon compliance with Minnesota Statutes, Section 645.021.
