

## CHAPTER 355—S. F. No. 2150

[Not Coded]

*An act relating to the tax levy for the road and bridge fund in the county of Goodhue.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Goodhue county; road and bridge tax levy.** Notwithstanding the provisions and limitations of Minnesota Statutes, Section 163.05, the board of county commissioners of the county of Goodhue may levy a tax not to exceed 35 mills on the dollar of the taxable valuation of the county for the county road and bridge fund.

**Sec. 2.** This act shall become effective only after its approval by the board of county commissioners of the county of Goodhue, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

## CHAPTER 356—H. F. No. 714

*An act relating to welfare; authorizing the creation of citizen advisory committees by county welfare boards; amending Minnesota Statutes 1967, Section 393.07, by adding a subdivision.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1.** Minnesota Statutes 1967, Section 393.07, is amended by adding a subdivision to read:

**Subd. 8. County welfare board; citizens advisory committee.** *In accordance with procedures established by the commissioner of public welfare, county welfare boards may appoint citizen advisory committees to consult with the board on any of the programs or services administered by the board. Within the limits of the appropriation provided, the board may authorize the reimbursement*

CHAPTER 357—H. F. No. 854

[Coded]

*An act relating to motor vehicles; authorizing issuance of temporary permits to nonresidents purchasing new motor vehicles in the state.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [168.091] **Motor vehicles; nonresident purchasers; temporary permits.** Subdivision 1. Upon payment of a fee of \$1, the registrar may issue a permit to a nonresident purchasing a new motor vehicle in this state for the purpose of allowing such nonresident to remove the vehicle from this state for registration in another state or country. Such permit shall be in lieu of any other registration or taxation for use of the highways and shall be valid for a period of 21 days. The permit shall be in such form as the registrar may determine and, whenever practicable, shall be posted upon the left side of the inside rear window of the vehicle. Each such permit shall be valid only for the vehicle for which issued.

Subd. 2. The registrar may issue a quantity of permits in booklet form to licensed dealers upon payment of the proper fee for each permit contained in said booklet. When the dealer issues a permit, he shall immediately forward to the registrar information on forms supplied by the registrar showing to whom the permit was issued, the vehicle description, date of issue and expiration, and such other information as the registrar may require.

Subd. 3. All payments received for such permits shall be paid into the state treasury and credited to the highway user tax distribution fund.
