
CHAPTER 62—S.F.No.2070

An act relating to highways; adding a new route to the trunk highway system in substitution of an existing route.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **TRUNK HIGHWAY SYSTEM; ROUTE 118.** There is added to the trunk highway system a new route described as follows:

161.115 Route No. 118. Beginning at a point on Route No. 45 southwesterly of Stillwater, thence extending in a westerly direction to a point on Route No. 394 in Roseville.

Sec. 2. The route established in section 1 is a substitute for Route No. 118 as contained and described in Minnesota Statutes 1974, Section 161.115, and said route as so contained and described in said section is discontinued and removed from the trunk highway system.

Sec. 3. The revisor of statutes, in compiling the Minnesota Statutes, shall substitute the route established in section 1 for the route discontinued and removed from the trunk highway system in section 2.

CHAPTER 63—S.F.No.2076

An act relating to corrections; amending Minnesota Statutes 1974, Section 241.01, by adding a subdivision.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1974, Section 241.01, is amended by adding a subdivision to read:

Subd. 8. CORRECTIONS; MEDIUM-MINIMUM SECURITY FACILITIES. When the commissioner prescribes criteria for the confinement of inmates in a correctional institution which he has designated a medium-minimum security facility, the criteria may include conditions of confinement, employment, conduct, instruction and discipline of inmates in that facility. The commissioner may utilize the services of the inmates in selected positions within the facility, except that they shall not exercise custodial functions over other inmates, and require them to pay the costs of their clothing and maintenance, including medical

and other correctional services. Those inmates pursuing approved educational and vocational training programs may be paid an educational stipend on a work-study basis.

When consistent with the public interest, the commissioner may grant furloughs to the inmates of medium-minimum security facilities for periods not to exceed five days, subject to criteria, terms and conditions as he shall prescribe, provided however, that no inmate convicted of an offense involving death, great bodily harm, criminal sexual conduct in the first, second or third degree, or who had a firearm in his possession at the time of the offense may be granted a furlough. No inmate may receive more than six furloughs in any 12 month period.

Sec. 2. This act is effective the day after final enactment.

CHAPTER 64—S.F.No.2168

An act authorizing the conveyance of lands and structures comprising Count Beltrami state monument to the town of Turtle Lake in Beltrami county; specifying the terms and conditions of such conveyance.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **CONVEYANCE OF STATE LANDS; BELTRAMI MONUMENT; TOWN OF TURTLE LAKE.** The governor, upon the recommendation of the commissioner of natural resources, may quitclaim and convey the state's lands and structures comprising Count Beltrami state monument, in Beltrami county, to the town of Turtle Lake, in Beltrami county, on the condition that the town agree to operate and maintain the monument, which is dedicated in honor of Count Beltrami to commemorate the discovery of the height of land on the Continental Divide on August 23, 1823. The lands and structures shall be conveyed in such form as the attorney general shall prescribe and the conveyance shall contain a provision that the lands and structures shall revert to the state in the event that the town of Turtle Lake fails to operate and maintain the same as a public monument to Count Beltrami.

Sec. 2. This act is effective the day following final enactment.
