"1Sp" preceding a chapter designates the 2003 First Special Session. Those sections marked "02-1Sp" refer to the 2002 First Special Session enactments that are included in Minnesota Statutes 2002. Actions taken at any later special session in 2003 are not included in this volume.

In the column labeled "Minnesota Statutes," the letters following section numbers show how each section has been affected. (N) indicates the tentative coding of a new section or subdivision. (A) indicates an amendment either to an existing section or to a section newly enacted this year or in 2002. (R) indicates a repeal.

Sections enacted in the 2002 First Special Session, indicated by "02-1Sp", are included in full in Minnesota Statutes 2002. Sections enacted in the 2003 Regular Session and the 2003 First Special Session will be included in full in 2003 Minnesota Statutes Supplement.

Sections marked (A) or (R) are existing sections of Minnesota Statutes. The changed portions of sections enacted in the 2002 First Special Session, indicated by "02-1Sp", are included in full in Minnesota Statutes 2002. The changed portions of sections enacted in the 2003 Regular Session or the 2003 First Special Session will be included in 2003 Minnesota Statutes Supplement.

Legislative action not fitting the categories "Amendment," "Repeal," and "New" is designated "Other action."
