All other laws listed in the table contain express requirements of local approval or are laws for which local approval certificates were filed regardless of whether the filing was required.

If a local approval certificate has been filed with the Secretary State in compliance with Minnesota Statutes, section 645.021, before August 9, 2005, the approval and filing dates are indicated. A blank space after a chapter citation indicates that a local approval certificate had not been filed by August 9, 2005.
