Sec. 2. Effective date. This act shall become effective only after its approval by a majority of the members of the county board of the county of Redwood, and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 163—S. F. No. 640

[Coded]

An act relating to counties; providing for the regulation and control of motor vehicles on parking facilities owned or operated by a county; providing penalties for the violation thereof.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [373.26] County parking facilities. Subdivision 1. No motor vehicle, either privately or publicly owned, may be parked upon any parking lot or facilities owned or operated by any county except as authorized by this act.

Subd. 2. Regulations by resolution. The board of county commissioners of any county may regulate, by resolution, the parking of motor vehicles, either privately or publicly owned, including the authority to make charges for parking privileges, upon any parking lot or facility owned or operated by the county.

Subd. 3. Enforcement. Regulations promulgated under the provisions of subdivision 2 shall be enforced by the county sheriff unless the county board has entered into a service contract for the enforcement thereof with the municipal council of the municipality in which the parking lot or facility is located.

Subd. 4. Removal and impounding of vehicles. Any motor vehicle parked upon any parking lot or facility owned and operated by the county not in conformity with the resolution of the county board regulating the operation and use thereof may be deemed a public nuisance and the county board may provide for the abatement of such nuisance by resolution.

Subd. 5. Penalties. Any person, state, or county official,

elective or appointed, firm, association, or corporation which violates any of the provisions of this act or resolution of the board of county commissioners adopted under authority of this act is guilty of a misdemeanor and upon conviction thereof, may be punished by a fine of not more than \$25 or by confinement in the county jail for not more than five days, or by both.

All fines imposed and collected by any court for violations of said regulations shall be remitted by said court to the treasurer of the county within 30 days after the collection of said fine.

Subd. 6. **Exclusion.** This act shall not apply to any county containing a city of the first class.

CHAPTER 164—S. F. No. 771

An act relating to state colleges; reappropriating moneys appropriated by Extra Session Laws 1961, Chapters 59 and 72.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **State colleges; reappropriations.** The moneys in the sum of \$45,000, appropriated to the commissioner of administration from the building outlay account in the state treasury by Extra Session Laws 1961, Chapter 59, Section 2, Subdivision 3, (j), (l), to remodel Deputy hall into classrooms and office space at Bemidji state college are hereby reappropriated to the commissioner of administration from the capital outlay account in the state treasury to remodel Deputy hall into classrooms and office space at Bemidji state college except that not more than \$10,000 thereof may be expended for equipment in connection with such project.

Sec. 2. The moneys in the sum of \$210,000 appropriated to the commissioner of administration from the 1961 Minnesota state building fund in the state treasury for land development, Highland campus, including walks, roads, parking, landscaping, but not including an intercampus road, by Extra Session Laws 1961, Chapter 72, Section 2, Subdivision 25,(2), are hereby reappropriated to the commissioner of administration from the 1961 Minnesota state building fund in the state treasury for land development, Highland campus, including walks, roads, parking, landscaping, and an intercampus road at Mankato state college. Not in excess of \$42,000
