

169.121 Motor vehicles—operation on frozen lakes; drivers under influence of drugs or alcoholic beverages. Subdivision 1. It shall be unlawful and punishable as provided in this section for any of the following persons to drive, operate or be in actual physical control of any vehicle within this state:

(a) A person who is under the influence of an alcoholic beverage or narcotic drug;

(b) A person who is an habitual user of narcotic drugs;

(c) A person who is under the influence of a combination of any two or more of the elements named in subsections (a) and (b) hereof.

The provisions of this subdivision apply, but are not limited in application, to any person who drives, operates, or who is in actual physical control of any vehicle in the manner prohibited by this subdivision upon the ice of any lake, stream, or river, including but not limited to the ice of any boundary water.

Sec. 2. Minnesota Statutes 1965, Section 169.13, is amended by adding a subdivision to read:

Subd. 4. Application. The provisions of this section apply, but are not limited in application, to any person who drives any vehicle in the manner prohibited by this section upon the ice of any lake, stream, or river, including but not limited to the ice of any boundary water.

CHAPTER 570—H. F. No. 288

An act relating to crimes and punishment; detaining one's own child outside the state; amending Minnesota Statutes 1965, Section 609.26.

609.26 Custody of children; detaining own child. Whoever intentionally ~~takes, confines or restrains~~ *detains* his own child under the age of 18 years *outside the state of Minnesota*, with intent to

CHAPTER 571—H. F. No. 346

An act relating to the state employees retirement association; amending Minnesota Statutes 1965, Section 352.04, Subdivision 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 352.04, Subdivision 2, is amended to read:

Subd. 2. **State employees retirement; maximum salary deduction; employee contributions.** The employee contribution to the fund (a) by those employees whose state service is covered by the federal social security act shall be an amount equal to three percent of salary, and (b) by those employees whose state service is not covered by the federal social security act shall be an amount equal to six percent of salary. These contributions shall be made by deduction from salary in the manner provided in subdivision 4. ~~No deduction shall be made from any salary in excess of \$7,200 in any calendar year.~~

Sec. 2. *This act shall become effective on the first day of the first pay period beginning after June 30, 1967.*
