

Subd. 7. The total credits allowed by subdivision 1 shall be deducted from the gross property tax before determination of the homestead credit provided by section 273.13, subdivisions 6 and 7 and the taconite homestead credit provided by section 273.135.

Sec. 8. EFFECTIVE DATE. This act is effective for taxes levied in 1980 and subsequent years and payable in 1981 and subsequent years.

CHAPTER 433—S.F.No. 1797

*An act relating to the Minnesota zoological garden; supplementing and clarifying the authority of the zoological garden board in regard to penalties for rule violations; regulating the use of the name or mark of the garden; providing penalties; amending Minnesota Statutes 1978, Section 85A.02, Subdivision 7; and Chapter 333, by adding sections.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1978, Section 85A.02, Subdivision 7, is amended to read:

Subd. 7. The board may enact ~~regulations~~ rules governing the efficient protection of the Minnesota zoological garden and the related facilities and the conduct of persons entering therein. ~~Regulations~~ Rules shall become effective in the manner provided by law for the promulgation of rules ~~and regulations~~ by state departments and agencies. ~~A~~ The violation of ~~any regulation~~ a rule promulgated by the board under this section is a petty misdemeanor. The board may specify that violation of a designated rule shall be sufficient cause for ejection from the grounds of the zoological garden.

Sec. 2. Minnesota Statutes 1978, Chapter 333, is amended by adding a section to read:

**[333.53] USE OF NAME AND MARK OF MINNESOTA ZOOLOGICAL GARDEN LIMITED.** Any person, firm, partnership, association, society, or corporation, not authorized by the Minnesota zoological board who, with intent to acquire or obtain for personal or business purposes a benefit or advantage, assumes, adopts or uses the name "Minnesota zoological garden", the trademark thereof or any other name or mark so nearly resembling the name "Minnesota zoological garden" or the trademark thereof as to be calculated to deceive or mislead the public with respect to the Minnesota zoological garden, or who, except as authorized by the Minnesota zoological board, with intent to acquire or obtain for personal or business purposes a benefit or advantage, assumes, adopts or uses any other name, mark, logo, emblem, insignia or badge, designation, or distinguishing descriptive word or phrase used by the Minnesota zoological board

in carrying out its purposes relating to the Minnesota zoological garden or any name, mark, logo, emblem, insignia or badge, designation, or distinguishing descriptive word or phrase confusingly similar thereto, calculated to deceive or mislead the public with respect to the Minnesota zoological garden, shall be guilty of a misdemeanor.

Sec. 3. Minnesota Statutes 1978, Chapter 333, is amended by adding a section to read:

[333.54] THREATENED USE MAY BE RESTRAINED. When there is an actual or threatened violation of section 2, an application may be made to a court having jurisdiction to enjoin and restrain the actual or threatened violation; and if it appears to the satisfaction of the court that the defendant is in fact using or threatening to use the name "Minnesota zoological garden" or the trademark thereof or any other name or mark confusingly similar, or any other name, mark, logo, emblem, insignia or badge, designation, or distinguishing descriptive word or phrase used by the Minnesota zoological board in carrying out its purposes relating to Minnesota zoological garden or confusingly similar to any other name, mark, logo, emblem, insignia or badge, designation, or distinguishing descriptive word or phrase used by the Minnesota zoological board in carrying out its purposes relating to the Minnesota zoological garden, the court may enjoin and restrain the actual or threatened violation without requiring proof that any person has in fact been misled or deceived thereby.

Sec. 4. This act is effective the day following its final enactment.

#### CHAPTER 434—S.F.No. 2168

*An act relating to historic sites; designating additional historic sites; requiring notice to the Minnesota Historical Society when the state or a political subdivision acquires certain property; amending Minnesota Statutes 1978, Sections 138.56, by adding a subdivision; and 138.59.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1978, Section 138.56, is amended by adding a subdivision to read:

Subd. 13. Sandstone school, owned by the school district of Sandstone, is in Pine County and is located in the city of Sandstone.

Sec. 2. [138.581] STATE HISTORIC SITES; REGISTRY; LANDS OWNED BY GOVERNMENTAL UNITS OUTSIDE THE STATE. Subdivision 1. The land and water areas enumerated in this section are designated "state historic sites," and this section is a registry of state historic sites situated on property owned by governmental units outside the state or by instrumentalities of those government units.
