28.7 period from enactment, which has since passed. The Department of Human Services was  
28.8 consulted in the preparation of this correction.

28.9 Subd. 11. **Obsolete subdivision.** This subdivision repeals obsolete language. Minnesota  
28.10 Statutes, section 256B.439, subdivision 3b, required the Department of Human Services to  
28.11 work with advisory groups to develop recommendations for a home and community-based  
28.12 services report card. Minnesota Statutes, section 256B.439, subdivision 3b, required the  
28.13 department to present the recommendations to the chairs and ranking minority members of  
28.14 the legislative committees and divisions with jurisdiction over health and human services  
28.15 by August 1, 2014, and to make the report card available on July 1, 2015. Both deadlines  
28.16 have since passed. The Department of Human Services was consulted in the preparation of  
28.17 this correction.

28.18 Subd. 12. **Obsolete subdivisions.** This subdivision repeals two subdivisions that applied,  
28.19 by their own terms, only to taxable years beginning after December 31, 2009, and before  
28.20 January 1, 2013.

28.21 Subd. 13. **Obsolete subdivision.** This subdivision repeals a subdivision that defines a  
28.22 term that is no longer used in the chapter. The Department of Human Services was consulted  
28.23 in the preparation of this correction.

28.24 Subd. 14. **Obsolete section.** The Department of Public Safety no longer requires a person  
28.25 to provide a purchaser's certificate to the department prior to registering a motor vehicle,  
28.26 making Minnesota Statutes 2022, section 297B.04 obsolete.

28.27 Subd. 15. **Obsolete section.** The Department of Public Safety no longer requires a person  
28.28 to provide a purchaser's certificate to the department prior to registering a motor vehicle,  
28.29 making Minnesota Statutes 2022, section 297B.05 obsolete.

28.30 Subd. 16. **Obsolete subdivision.** Minnesota Statutes 2022, section 299F.851, subdivision  
28.31 7, allowed the resale of cigarettes that did not meet certain testing standards if those cigarettes  
28.32 were purchased from a wholesale or retail dealer prior to December 1, 2008. The Department  
28.33 of Public Safety confirmed that this exception is obsolete.

29.1 Subd. 17. **Obsolete rule part.** This subdivision repeals an obsolete rule to comport with  
29.2 changes Minnesota Statutes, section 626.892, subdivision 7 (section 189 of this bill).  
29.3 Minnesota Rules, part 5530.1000, only contains cross-references to recodified rules. By  
29.4 amending Minnesota Statutes, section 626.892, subdivision 7, to reference the recodified  
29.5 rules, Minnesota Rules, part 5530.1000, is now obsolete.

29.6 Subd. 18. **Obsolete rule part.** Minnesota Rules, part 7805.0300 was included in the  
29.7 Department of Transportation's annual Obsolete Rules Report.

29.8 Subd. 19. **Obsolete rule part.** Minnesota Rules, part 8810.4100 was included in the  
29.9 Department of Transportation's annual Obsolete Rules Report.

29.10 Subd. 20. **Conflict resolution.** This subdivision resolves a conflict between two enacted  
29.11 laws. Minnesota Statutes, section 245.462, subdivision 17, was amended by Laws 2021,  
29.12 chapter 30, article 17, section 16, which struck all text except the first six words. Minnesota  
29.13 Statutes, section 256.462, subdivision 17, was subsequently amended again in Laws 2021,  
29.14 First Special Session chapter 7, article 11, section 1, which added paragraph (b), clause (5),  
29.15 and still contained all of the language struck by Laws 2021, chapter 30, article 17, section  
29.16 16. Because the two amendments could not be merged editorially, the later enacted  
29.17 amendment, the First Special Session chapter 7 amendment, was printed in the main text  
29.18 and the chapter 30 amendment was printed as a note. This repealer allows the revisor to  
29.19 remove the note containing the amendatory language.
